I. Meeting called to order by Chuck Clark at 11:02 am

## II. Approval of agenda

 a. Motion to approve the agenda by Babara Hamley, seconded by Babara Sacks, motion approved

#### III. Item of discussion

- a. Budget discussion for UF's "The Big Event: Service Day" led by UF students, to purchase cleaning supplies for the community service project to pick up trash within the district.
  - i. Chuck Clark provided a overview of the service day, the location in which the volunteers would pick up liter, and requested to purchase cleaning supplies such as safety vest, garbage bags, and pick up sticks
  - ii. Discussion that Council would provide snacks for the volunteers from personal funds
  - iii. Discussion regarding the Council member signing the indemnity form.

    Program Manager) mentioned that the County Attorney did review the

    language of the form and has requested suggested changes for sovereign

    immunity as the District is a form of local government. It was suggested

    that the Council wait to hear from the County Attorney before signing and
    submitting any documents to UF for the Big Event

- iv. Greta Moreau (Code Administration Interim Director) mentioned she would reach out to Public Works to request if they could provide vest and litter pick up sticks
- v. Motion to approve the use of the budget to purchase litter pick up sticks, vest, and trash bags and not to exceed \$175 by Barbara Hamley, seconded by Barbara Sacks, motion approved.

#### IV. Public Comments

- a. William Chason (Code Administration Code Officer) provided an update regarding trash cans are being pulled back and reaching out to tenants that need trash cans repaired for example those that are missing wheels and have slits on the side. Also all shopping carts and bulk items have been removed from the neighborhoods
- b. Greta Moreau, provided updates on 2 properties that were mentioned up at the January 3, 2024 district meeting, one being an active code violation case and the second property will go before the magistrate for not being boarded correctly after a fire incident

#### V. Council Comments

- a. Chuck Clark provided an update that the community signs have been installed, but missing lights. Satori Days mentioned she would reach out to the vendor for updates on the lights. Council members mentioned they would add flowers around the signs.
- b. Chuck Clark provided an update that the cable was buried as mentioned during the January meeting
- c. Chuck Clark provided an update that he reached out to Public Works to inquire if they could install the sidewalk in sections as they current budget would not allow for the entire sidewalk project to be completed and that they would follow up with him.
