Alachua County Forever was established to protect the finest examples of Alachua County's natural communities, endangered species, and rich biological diversity. The citizens of Alachua County authorized the Alachua County Forever (ACF) program by public referendum in November, 2000. The referendum provided ad valorem revenues to support \$29 million in bond funds for the acquisition and management of environmentally significant lands. Voters re-authorized funding with the Wild Spaces & Public Places referendum first in 2008, then 2016, and most recently in 2022, providing additional funding through sales tax proceeds. In 2024, the Board of County Commissioners authorized an ACF program strategy that expands protection of agricultural lands through acquisition of conservation easements on priority farm and ranch lands. Conservation corridors, public access, passive recreation and environmental education, and support for local food systems are addressed as components of the overall acquisition and conservation objectives of the program.

Two citizen Boards authorized by the Board of County Commissioners represent the citizen voice in review of lands which are nominated to the program. The Land Conservation Board (LCB) reviews property for possible acquisition for the protection of environmentally significant lands, while the Agricultural Land Conservation Board (ALCB) reviews lands nominated for agricultural conservation easements in Alachua County. All proposed purchases must be submitted to the Board of County Commissioners for final approval prior to initiating a contract purchase.
