

NEVER FLUSH IT



The Alachua County Environmental Protection Department offers a safe and environmentally responsible service for the disposal of unwanted medication free of charge to Alachua County residents.

Unwanted medicines can be dropped off for proper disposal at the Alachua County Hazardous Waste Collection Center (HWCC) and at specific alternate County locations. Call (352) 334-0440 for disposal locations, directions and more information on this free program.

Alachua County's service accepts prescription and over-the-counter medications (including pills, gel caps, capsules or liquids) that are unwanted, expired, damaged or unusable for their intended purposes.

NARCOTICS OR CONTROLLED SUBSTANCES ARE **NOT** ACCEPTED DUE TO FEDERAL REGULATIONS.

Environmental Concerns About Improper Disposal of Unwanted Medicines:

- It is advised to NEVER flush medication down sinks, drains or toilets.
- Disposing of medicine into your trash can result in accidental poisoning to children and pets and the potential of diversion or theft of medicine prescribed to you.
- Disposing of unwanted pharmaceuticals and medicine in domestic sewage systems is causing scientific and national concerns due to the potential threat to aquatic life and human health from exposure to surface and groundwaters which receive discharges from domestic sewage treatment systems.
- Current sewage treatment systems are ineffective in removing low levels of pharmaceuticals in the treated waste stream.


